These terms and conditions outline the rules and regulations for the use of our website and services provided by 1194 Creative.

1. Definitions

"Services" encompass all Website Design, Artworking, Print Management and Graphic Design, and related services provided by 1194 Creative.

2. Services

1194 Creative offers Website Design, Artworking, Print Management and Graphic Design related services to clients. All services provided by 1194 Creative are subject to individual agreements and project scopes agreed upon with the client.

3. Client Responsibilities

Clients are responsible for providing clear project requirements and content necessary for the completion of the project. Timely communication and feedback from the client are essential for the successful completion of all projects. There is a strict one week deadline for all content to be provided to us so we can complete your website. Failure to provide us with any information for your website may result in a cancellation of your website and only a 50% refund will be provided. 1194 Creative reserves the right to only provide a partial refund due to not supplying us with content within the timeframe suggested. We will be delayed in other work if you do not provide us with the necessary information in time, so we can build your website as this can have a knock on effect on other clients projects due to these delays.

4. Fees, Payments & Refunds

Fees for 1194 Creative services are outlined in individual proposals and agreements. Payment terms and schedules are specified in each agreement and must be adhered to by the client. All payments for our services are to be made via BACs/Bank Transfer only. All payments are to be made upfront and 100% of payment is required before any work begins. We do not offer any payment plans. We do offer an 100% client satisfaction policy, if you are not happy with the works carried out we will arrange a redesign of any

service until you are 100% happy with the work. Full refunds can only be provided if there is a satisfactory reason to allow for this. All payments come with receipts or order confirmations.

5. Intellectual Property

All intellectual property rights associated with the design work created by 1194 Creative belong to 1194 Creative until full payment has been received from the client. Upon full payment, ownership of the intellectual property rights associated with the design work transfers to the client.

6. Confidentiality

1194 Creative and the client agree to maintain confidentiality regarding any sensitive information shared during the course of the project.

7. Limitation of Liability

1194 Creative is not liable for any indirect, incidental, or consequential damages arising from the use of our services or website. 1194 Creative are not responsible for the financial performance, sales increase, site traffic or popularity of your website due to any of our services. 1194 Creative are not responsible for your ranking on Google or other search engines. 1194 Creative are only designers, not developers. Meaning that we do not use coding for design, meaning that there are some limitations we might come across when designing your website.
